**ADMINISTRATIVE ORDINANCE NO. 11 - 2009**

**ADMINISTRATION BILL NO. 11 - 2009**

**INTRODUCED –JUNE 9, 2009**

**ADOPTED BY COUNCIL - JUNE 23, 2009**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LANCASTER, LANCASTER COUNTY, PENNSYLVANIA ESTABLISHING APPROPRIATIONS FOR \$35,000 OF GRANT REVENUE EXPECTED TO BE RECEIVED IN 2009; PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES; PROVIDING FOR THE SEVERABILITY OF THE ORDINANCE; AND PROVIDING THAT THE ORDINANCE SHALL TAKE EFFECT AS PROVIDED BY PENNSYLVANIA LAW.**

**WHEREAS**, Section 1804 of the Third Class City Code, Act of June 23, 1931, P.L. 932, Number 317, reenacted and amended June 28, 1951, P.L. 662, Number 164, as amended, provides, inter alia, that, “No money shall be paid out of the city treasury except upon appropriation made according to law and on warrant drawn by the proper officer and pursuant thereof;” and

**WHEREAS**, Section 1804 of the Third Class City Code as set forth above further provides, inter alia, that, “The council may at any time by ordinance make supplemental appropriations for any lawful purpose from any funds on hand or estimated to be received within the fiscal year and not appropriated to any other purpose...;” and

**WHEREAS**, The City Council of the City of Lancaster anticipates that it will receive grant revenue in the amount of \$35,000.00 in 2009 for which appropriations have not been made; and

**WHEREAS**, The City Council of the City of Lancaster desires to appropriate such \$35,000.00 for the salary of a Public Arts Manager for the remainder of 2009.

**NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED** by the City Council of the City of Lancaster, Lancaster County, Pennsylvania, as follows:

**SECTION 1.** The provisions of the background clauses set forth above be and hereby are incorporated herein.

**SECTION 2.** The City Council of the City of Lancaster hereby appropriates the \$35,000 expected to be raised from the Lancaster County Community Foundation Grant in 2009 to the following expenditures:

A. Director – Public Works: Salaried Personnel - \$35,000.00

SECTION 3. The appropriate officers of the City of Lancaster be and hereby are authorized and directed to utilize the \$35,000.00 received from the Lancaster County Community Foundation for the appropriations set forth in SECTION 2 above.

SECTION 4. All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith are hereby repealed and rescinded.

SECTION 5. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any of the remaining provisions, sections, sentences, clauses or parts of this Ordinance; it being the intent of the City of Lancaster that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 6. This Ordinance shall become effective as provided by the laws of the Commonwealth of Pennsylvania.
