AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LANCASTER, LANCASTER COUNTY, PENNSYLVANIA AMENDING THE CODE OF THE CITY OF LANCASTER, CHAPTER 67 – POLICE BUREAU, SECTION 67-1 – COMPENSATION AND GRADES TO PROVIDE THAT THE POLICE BUREAU SHALL BE COMPOSED OF SUCH DIVISIONS, NUMBERS OF SWORN OFFICERS AND RANKS AS DETERMINED BY THE POLICE CHIEF AND MAYOR; AMENDING SECTION 67-2 – CHIEF OF POLICE TO PROVIDE THAT THE DIRECTION, SUPERVISION AND CONTROL OF THE BUREAU OF POLICE SHALL BE VESTED IN THE CHIEF OF POLICE ACTING UNDER THE DIRECTION OF THE MAYOR; AMENDING SECTIONS 67-5, 67-7 AND 67-9 TO PROVIDE THAT ALL OF THE SUPERVISORY ITEMS SET FORTH IN THOSE SECTIONS ARE AT THE DIRECTION OF THE CHIEF OF POLICE AND THE MAYOR AND TO REVISE THE PROMOTION PROCEDURE GRADING; PROVIDING FOR THE REPEAL OF INCONSISTENT ORDINANCES; PROVIDING FOR THE SEVERABILITY OF THE ORDINANCE; AND PROVIDING THAT THE ORDINANCE SHALL TAKE EFFECT AS PROVIDED BY PENNSYLVANIA LAW.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED AND ENACTED by the City Council of the City of Lancaster, Lancaster County, Pennsylvania, as follows:

SECTION 1. The Code of the City of Lancaster, Lancaster County Pennsylvania, Chapter 67 – Police Bureau, Sections 67-1, 67-2, 67-4, 67-5, 67-7 and Section 67-9 be and hereby are amended as set forth on the attached highlighted version of Chapter 67 of the Police Bureau detailing such changes.

SECTION 2. All ordinances or resolutions or parts of ordinances or resolutions insofar as they are inconsistent herewith are hereby repealed and rescinded.

SECTION 3. In the event any provision, section, sentence, clause or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any of the remaining provisions, sections, sentences, clauses or parts of this Ordinance; it being the intent of the City of Lancaster that the remainder of the Ordinance shall be and shall remain in full force and effect.

SECTION 4. This Ordinance shall become effective as provided by the laws of the Commonwealth of Pennsylvania.
