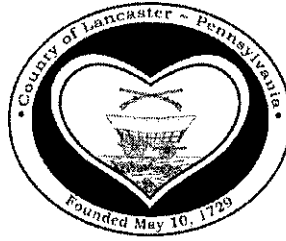

PROCLAMATION

225th Year Anniversary of Lancaster Newspapers

July 24, 2019

WHEREAS, LNP Media Group, Inc., traces its roots to one of the oldest newspapers in the U.S., *The Lancaster Journal*, which dates to 1794, when William Hamilton and Henry Willcocks printed five hundred copies of the four-page first edition on a hand operated wooden press; and

WHEREAS, the "Lancaster Journal" merged with the "Lancaster Intelligencer and Weekly Advertiser" in 1839; and

WHEREAS, the Daily New Era was first published April 28, 1877 and in 2009, Lancaster's two daily newspapers, the morning Intelligencer Journal and the evening Lancaster New Era, which were both published by Lancaster Newspapers and headquartered in the same building, were merged to form the Intelligencer Journal-Lancaster New Era; and

WHEREAS, their sister paper, the Sunday News, which was first published September 23, 1923, joined the combined newsroom in 2012; and

WHEREAS, in 2014, the Intelligencer Journal-Lancaster New Era, along with the Sunday News, were combined, rebranded, and renamed LNP. The first issue of the newly renamed LNP was published on October 16, 2014.


WHEREAS, under its current header, LNP adopted the tagline Always Lancaster. The rebranding was "aimed at representing and embracing the history of Lancaster County,"; and



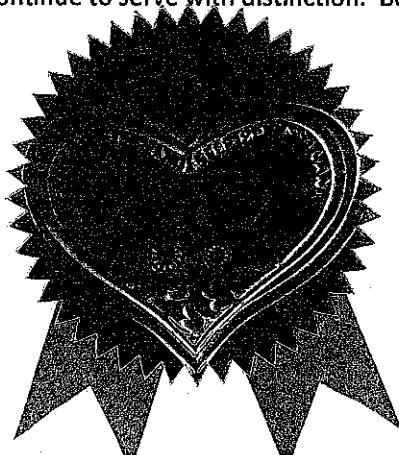

No monies or any other form of financial benefit shall be exchanged between the parties for services rendered or received.

Term:

This Agreement shall commence on the date that it has been fully executed by both parties and all approvals required by Commonwealth contracting procedures have been obtained, and shall remain in full force and effect until terminated by either party.

Note:

This replaces the Agreement with the Pennsylvania Department of Corrections, approved by the County on June 26, 2019, which was limited to K-9 searches at the Prison.
