Please read this information carefully and feel free to ask any questions if you do not understand something.

- First & foremost, thank you for participating in the completion of what may have been referred to you as the "GPRA tool." GPRA stands for Government Performance Results Act.
- Funding for your current treatment experience is being provided by a special fund called State Opioid Response or SOR. It is only available to you if you have a substance disorder for opioids and/or stimulants.
- In order for the funding to continue to be available for yourself and others, we are required to collect certain data (GPRA tool) and report it three (3) different times. **The first time is now.**
- **We will need to contact you two (2) more times:**
 1. In five (5) to eight (8) months
 2. When you are discharged from your treatment continuum (which may include lower or higher levels of care after this placement.)
- When you are contacted, you will be asked to provide responses to the information needed on the GPRA tool. The reason for this tracking is directly related to the funding being utilized for your SUD services.
- Your name and any personal identifying information IS NOT released.
- By signing this document, it will confirm someone has explained to you that over the next five (5) to eight (8) months a designated treatment/treatment related professional will be following up with you at various intervals.
- The consents you have signed will permit the professional contacting you to locate you if your direct contact information is no longer valid. In other words, the professional may need to reach out to your alternate contacts to locate you. The GPRA data is vitally important for the continuation of the SOR funding; therefore, locating you to acquire the needed data is of the utmost importance.
